1 WHEREAS, on October 29, 2018, the Court held a hearing on Plaintiff's motion for final
2 approval of the class action settlement, and the Court instructed the parties to meet-and-confer,
3 consult with the Claims Administrator and submit a stipulation specifying a cap on Notice and
4 Claims Administration Expenses, as that term is defined in the Second Amended Settlement
5 Agreement;

6 WHEREAS, Plaintiff's counsel has consulted with the Claims Administrator and met-and-
7 conferred with Defendant's counsel, and the parties agree that an appropriate cap for Notice and






